



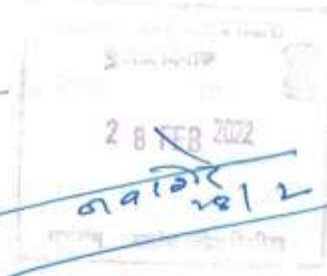

affiliation & examination byelaws, directions issued from time to time and the law of the land.

- viii** That, the school will ensure compliance of all statutory requirements like EPF, ESI and labour Laws etc. with respect to the school and staff of the school.
